MTB BICYCLE RENTAL AGREEMENT

Article 1.

The subject of this Agreement is the rental of: MTB BICYCLE GIANT TALON 29 3, size _____,
marking: _____ with the accompanying additional equipment: protective helmets, saddle bags and
bottle cage.

Article 2.

The Lessee confirms that he has checked the condition of the MTB bicycle he has taken over and that he
has taken over a mechanically functional MTB bicycle with the associated additional equipment (safety
helmet, under-seat bag and bottle cage).

The rental begins on _____ at ____ : ____ h and ends on the same day at ____ : ____ h.

The Lessee undertakes to return the bicycle to the location where the bicycle was picked up.

Article 3.

The rental price is: _____ euros. The Lessee will be issued an invoice for the paid rental.

Article 4.

The contracting parties agree that, if necessary, the lessee will be charged other fees in the following amounts:

- *late fee*: in addition to the rental fee, which will be calculated in accordance with the Price List and depending on the hours of delay,
- *fee for damage to the bicycle and/or equipment*: in the amount of 80% of the retail price of the damaged bicycle and/or equipment,
- *fee for leaving the bicycle outside the pick-up location without prior agreement with PP Biokovo*: in the amount of 80% of the retail price of the bicycle and equipment,
- *compensation for damage in the event of bicycle theft*: in the full amount of the damage incurred, which includes the material value of the bicycle and the Lessor's lost profit caused by the theft.

Article 5.

The Lessee undertakes to:

- use the bicycle carefully and exclusively for recreational purposes for personal needs and not to use it for sports races or under the influence of alcohol or drugs,
- to behave responsibly in traffic and assumes all responsibility for any damage or injury caused by failure to comply with traffic and safety rules,
- not to lend the bicycle to third parties or sublet it,
- to be responsible in the event of theft, damage or loss of the bicycle,
- to return the bicycle to the pickup location, with additional equipment within the agreed time and in the condition in which it was picked up,
- to immediately inform PP Biokovo of any possible bicycle malfunction, traffic accident, damage or other extraordinary circumstances and of any delay in returning the bicycle due to the above at the telephone number +385(0)21 733 017.

Article 6.

The Lessor undertakes to:

- deliver a technically sound bicycle with undamaged additional equipment,
- provide the Lessee with basic instructions on using the bicycle and possible bicycle routes,
- accept the returned MTB bicycle and check the condition of the returned bicycle and additional equipment.

Article 7.

In the event that the Lessee does not return the bicycle at the agreed time or does not contact the Lessor by phone in the event of extraordinary circumstances, the event shall be reported to the competent Police Station in Makarska with the Lessee's details.

Article 8.

The Agreement may be terminated: upon expiry of the Agreement, by mutual agreement or unilaterally in the event of breach of contractual obligations.

Article 9.

The General Terms and Conditions of MTB Bicycle Rental and the valid Price List are attached to this Agreement.

By signing this Agreement, the Lessee confirms that he is familiar with the General Terms and Conditions of MTB Bicycle Rental of the PP Biokovo and the valid Price List and accepts them together with this Agreement.
